

The GiveMN Privacy Policy

Our approach to privacy is simple—we are vigilant about protecting your privacy at all times. Your use of the Website implies acceptance of this Privacy Policy and the Terms of Use. If you do not accept any aspect of the Policy you should not use the Website.

This policy is designed to assist you in understanding what information you may be asked to provide, how the information is used and shared, and how you can control the information via our website, GiveMN.org (aka “Website” or “givemn.razoo.com”). We will not use or share your information with anyone, except as prescribed in this Privacy Policy (aka “Policy”).

Information We Ask You to Provide

If you choose to create an account with us and become a member, you will be asked to select a username and password. We will ask you to provide certain personal information, such as first name, last name, and email address, in creating your user profile. Once created, the user profile will be viewable by the general public. (You may, however, disable this option via your profile settings.)

Razoo LLC (aka “Razoo”) is a partner company that provides the online infrastructure for GiveMN.org (“GiveMN”) in order to connect donors with nonprofits. User accounts are shared between GiveMN and Razoo. Other content shared between the two websites include:

- Organization information
- User profiles
- Fundraisers created by donors
- Projects created by nonprofits
- Donor comments and any other user-generated content

As such, your activities on the GiveMN will also be governed by Razoo’s Terms of Use and Privacy Policy.

GiveMN and Razoo have access to all information you submit to the Website. If you create an account with us, we may send a monthly newsletter, system messages pertaining to account information, and other communications to your email. You may opt out of the monthly newsletter by adjusting the settings in your user account.

You may also post information, such as comments, texts, images, videos, and other content (aka “Materials”) to the Website. Any Materials you post to the Website may be viewable by the general public and are governed by our Terms of Use.

Our Use of Information You Provide

We will use the information you provide only to complete your donation and to provide you with tools to manage and monitor your transactions. The Minnesota Community Foundation

("MCF") is a partner nonprofit that accepts all donations that come through the Website. When you make a donation to a nonprofit listed on the Website, you grant us permission to access your donation records at any time. We will make available to your selected nonprofit online reports identifying, where available, the name, address, email, and transaction accounting details of the donation. If you choose to make your donation anonymously, we will share only the donation amount with the nonprofit. Neither MCF nor we will, however, ever share your personal information, donation activity, or email address with any third party without your prior written consent.

We will use your contact information to send you information concerning your donation, including without limitation a donation confirmation and any notices about problems with your credit card.

Security

GiveMN and Razoo take security seriously and we take reasonable measure to protect our user's information. All transaction and credit card information entering the Razoo system is encrypted using SSL certificates from VeriSign. GiveMN and Razoo are not, however, responsible for any information your share with other users of the Website or other third parties.

Privacy Protection for Children

In compliance with the Children's Online Privacy Protection Act, we will not knowingly permit persons under the age of 13 to provide information to us through the Website or otherwise. If we later learn that any user is under the age of 13, we will take appropriate steps to remove that user's information from the database and restrict that user's access to the Website.

Links to Other Websites

The Website may contain links to third-party websites, including nonprofits and other organizations. GiveMN and Razoo are not responsible for the privacy practice, policies, or content of such websites.

Legal Requirements

Although such a situation may be unlikely, GiveMN and Razoo may be required to disclose user information to appropriate authorities in accordance with law, whether by subpoena or other legitimate request.

Notification of Changes

If we decide to use your information in a manner different from that stated at the time of collection, we will notify you via email. You may choose whether or not we may use such information in this manner. In addition, if we make any material changes in our privacy practices that do not affect your information already stored in our database, we will post a prominent notice on the Website notifying you of the change. In some cases when we post such

notice, we may also email you, notifying you of the changes to this Policy.

We believe strongly in respecting your privacy. We will update and amend this Policy if and when it is necessary. Please check back often to read the most updated and amended Policy.
